Customs Services	 For all circumstances where more is required than the standard clearance procedure, DHL Express offers additional clearance services. Bonded Transit. Upon request, the transit of a shipment under customs bond. 	- Preferential Origin. At request, DHL prepares a Certificate of Origin or other similar to certify the goods in a particular export shipment have been produced or manufactured in a particular country, allowing preferential rates of duty to be claimed at destination. 	- Bonded Storage. Storage charges apply when the shipment cannot be released by customs due to inaccurate or missing paperwork. Charges are effective three calendar days after the freight arrival date or broker notification, whichever is later. 	- Export Declaration. Applies in countries where an export declaration is required for shipments containing controlled commodities or exceeding € 1,000.00 or a certain weight.
