## PROHIBITED ITEMS



- **Bullion**
- **Cash and travellers cheques**
- **Complete original and imitation firearms and firearm parts** Including rifle butts, trigger mechanisms, screws / bolts etc which are manufactured for the sole purpose of creating a functional firearm, ammunition, explosives /explosive devices.
- **Clinical and / or biological samples** (including but not limited to human/animal bodily fluids and / or tissue samples)
- **Dangerous/hazardous goods** including but not limited to perfumes, aftershaves, aerosols, flammable substances, dry ice, biological substances, UN classified dangerous goods and any goods specified as such under IATA (International Air Transport Association), ICAO (International Civil Aviation Organisation), ADR (Agreement on Dangerous Goods by Road) or IMDG (International Maritime Dangerous Goods) regulations.
- **Electronic cigarettes**
- **Furs**
- **Human and animal remains or ashes**
- **Illegal goods and ivory** this can include items that are country-specific (e.g. the importation of alcohol) and commodities considered to be illegal internationally, such as counterfeit goods, ivory and narcotics
- **Live animals** (including but not limited to mammals, reptiles, fish, invertebrates, amphibians, birds, insects, larvae and pupae)
- **Lithium batteries and / or powerbanks**
  - **All lithium-metal batteries**  
Lithium-metal batteries are generally non-rechargeable and contain metallic lithium
  - **Loose lithium-ion batteries**  
Lithium-ion batteries do not contain metallic lithium and are rechargeable
- **Loose precious and semi-precious stones**  
Cut or un-cut, polished or un-polished.
- **Pornography**  
Whether in printed, film or digital format, or adult toys

## RESTRICTED ITEMS



- **Antiques, works of art and fine art\***
- **Jewelry, costume jewelry, watches\*** and objects constructed of precious metal and/or stones.
- **Laptop computers\***  
No more than 1 laptop computer per package. Each package may not contain more than one 1 lithium-ion battery which must be contained within the laptop. The package may not display a label that is equal or similar to this example. \*\*
- **Small electronic items\***  
Including mobile phones, containing lithium-ion or lithium-metal batteries. The batteries (max. 2) must be contained within the electronic device. The package may not display a label that is equal or similar to this example. \*\*
- **Tobacco\***  
Loose leaf tobacco products and pre-rolled cigarettes.

\* With a value not exceeding € 2000.- per shipment.

\*\* A package containing a laptop computer or small electronic devices may not display a label equal or similar to this example.
